# What information do my legal, financial and tax advisors require?

It is vital that the legal name of the Scholarship and Bursary Society be specified in your will or when you name CFUW Victoria as a beneficiary. The official name is 'Canadian Federation of University Women Victoria Scholarship and Bursary Society'.

# What is the BN/Tax registration number for the Scholarship and Bursary Society?

119260768 RR 0001. Your legal, financial and tax advisors will need to know this.

#### How will my legacy gift be acknowledged?

Upon receipt of a gift, your estate will be issued a tax receipt. With your permission, we'll notify Club members of your bequest in our club communications.

# Will any third parties receive compensation?

CFUW Victoria S&B will not compensate, whether through commissions, finder's fees or other means, any third party for directing a legacy gift or a donor to CFUW Victoria Scholarship and Bursary Society.

# What happens if CFUW Victoria were to fold?

As stated in CFUW Victoria S&B Bylaws, all remaining funds, after payment of all liabilities, from the Society would be sent to a recognized charitable organization within British Columbia.
